
On May 31, 2022, AMSSA's Migrant Worker Hub held a webinar on this topic with speakers Shanisse Kleuskens, Sophie Lemieux and Ashley Forgie from Employment and Social Development Canada (ESDC). Speakers shared with us an introduction and overview of Job Bank, how to support migrant workers to utilize Job Bank to search for employment, along with tips and resources for migrant workers using the Job Bank for best results.

INTRODUCTION


Migrant worker support organizations expressed a need for an orientation and training on the <u>Government of Canada Temporary Foreign Worker Job Bank</u>. This webinar and this accompanying handout enable front line support workers to be able to guide migrant workers in searching and applying for positions listed on Job Bank, increasing the probability of labour market attachment in Canada for migrant workers.



JOB BANK TOOLS & SERVICES OVERVIEW

Temporary Foreign Workers (TFWs) have the right to change employers while they are in Canada. They can use the Job Bank to find a new job, and other useful information for free. The Job Bank consists of interconnected tools and services. In 2020-2021, the Job Bank received over 160,000 site visits and 740,000 page views per day. Job Bank offers the following resources and tools to prospective candidates:

- · Job Bank Mobile App: available for browsing jobs on the go
- · Job Alerts: can be set-up to send you an email notification when new job opportunities are available
- · Job Match: create a profile and be matched to jobs that suit you



TEMPORARY FOREIGN WORKER PROGRAM

The Temporary Foreign Worker Program (TFWP) enables employers to fill labour and skills shortages on a temporary basis when Canadians and permanent residents are not available. TFWs have the same rights as Canadians working in Canada to change jobs, access Employment Insurance, etc. Employers looking to hire under the TFWP need to complete the Canadian government's labour market test, known as the Labour Market Impact Assessment (LMIA).

Information on employers who were issued a positive LMIA can be found on Open Data.

The <u>TFW page on Job Bank</u> has up-to-date job postings linked with Labour Market Impact Assessments. It is a trusted source of information with a multilingual landing page. Job Bank provides referrals to resources and important information for migrant workers seeking employment opportunities in Canada. It does not simplify or change existing immigration processes or TFWP requirements. Job Bank differentiates between LMIA-approved and LMIA-pending job postings.

- The LMIA is pending The employer has asked permission to hire a foreign worker to fill a job temporarily.
- The LMIA is approved The employer already has permission to hire a foreign worker to fill a job temporarily.

If their LMIA is already approved, the TFW may be able to start working for that employer right away.


🌍 Note: The employer is not allowed to make a TFW pay for the Labour Market Impact Assessment.

Suspect a misleading or fraudulent job posting?

The Job Bank allows users to report a problem with a job posting and report misuse of the TFWP. An employer **cannot** penalize a TFW or have them deported for reporting them.
